Upcoming Levies

Mindy gave an introduction of the three levies that will be on the February 8, 2022 ballot. Information about 2022 levies is on LWSD website.

The Educational Programs and Operations (EP&O) Levy and School Technology and Capital **Projects Levy** are renewal levies. They fund staff, programs, early learning, technology and help ensure our school buildings are safe and maintained.

The Building Excellence Capital Levy is a new levy and it will fund school construction to make sure our students have room to learn in our fast-growing district.

Stephanie Justus asked in chat,

"What \$\$ contribution from PTSA is suggested towards these levies?" Mindy Linciome answered that if your PTSA vote to endorse the levies, PTAs usually donate be \$150-300, sometimes more n if it is a ballot year.

"What purpose will this \$\$ contribution serve to the campaign?" The citizens levy committee is a nonprofit org, just like the PTSA, so any donations keep the org running and pay for admin costs, printing fees, marketing, etc., even in non-campaign years.

Vote to add budget line item for levies/bonds
